Roy Heywood 1949 - 2012

It is with great regret to note that Roy Heywood, my friend and colleague passed away on Saturday 25th of February aged 62. I had known him for more than forty years.

Roy joined Wildy's in 1967 and started to learn his trade as a junior sales assistant in our bookshop. Much in common with Law Librarians at the time, these were the days when a huge amount of information had to be retained in one's head; there were no electronic data bases for ease of reference and records were kept by card index or by updating catalogues. And so it was that the first chapter in what became Roy's vast book of bibliographic knowledge was written.

In 1970 Roy left Wildy's to join Butterworths in their legal bookshop, but returned in 1975 to take up the role of Manager of our New Books Department at Lincoln's Inn. Over the ensuing years, Roy worked in most departments throughout the company and became a Director in the early 1980's.

In more recent years, Roy's principal responsibilities were running our Antiquarian Department along with our Sets and Multi-volume Reports Department; by which time his knowledge of English law books ranged from the latest student textbooks, right back to fine antiquarian volumes, a truly remarkable achievement. (The company has records of books and documents going back to the year 1500).

In 2007 Roy moved to our warehouse and distribution centre in Leighton Buzzard which was closer to his home and where he could immerse himself amongst some of our more interesting legal tomes that he knew and loved so well.

Roy retired from the company in September 2009, but in recent months he had become seriously ill. Despite this, he was surprisingly upbeat and cheerful when I went to visit him a couple of weeks prior to his passing – he was clearly resigned to the fact that he didn't have too long to go and was busy sorting out his affairs. We sat chatting for several hours, recounting stories of our time together at Wildy's and laughing and joking about many amusing and bizarre events that we had shared over the years.

One of Roy's last requests was to have his wake held at his beloved MK Dons and he heard that his wish had been granted, just before he passed away.

Roy's quiet and thoughtful manner, coupled with a sharp sense of humour, endeared him to his colleagues and customers from all over the world, some of whom had known him for more than four decades. He will be sadly missed by us all.
