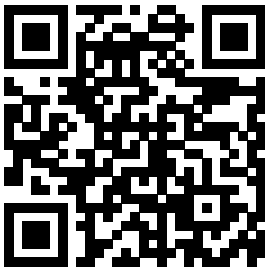
We are pleased to publish the reprint of Geoffrey MacCormack's classic Traditional Chinese Penal Law as part of our Law in East Asia Series (see page 65).

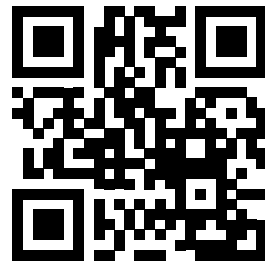
Congratulations to LexisNexis on their successful move from Chancery Lane to Farringdon Street. Other companies move around but we have stayed in the same location for over 180 years.
