
AccessToLaw is a legal gateway service, started in 2000, which is compiled by Inner Temple Library staff. At the moment there are links to over 1,000 sites.







This book is a fictionalized account of a young Indian girl's struggles to become a lawyer. It is a lighthearted but very real account of the problems encountered.




