#### **Inn Libraries Proposed Merger**

Feasibility Study to consider the possible merger of the Inner and Middle Temple Libraries

The results of the study are likely to be available in the late summer and no decisions are anticipated until much later in the year, after full consultation with staff and consideration by the relevant Inn Committees, Bench Table and Parliament.

In particular, no assumption has been made as to which Inn would house the Library and which the Education Centre, should the project proceed.







#### Roy Heywood writes:

Harold I. "Deke" Boucher was introduced to me initially, by an American Law Librarian, as a benefactor. The librarian, now the Rare Books Librarian at Yale University, Lillian Goldman Law Library, continued to receive donations from Mr. Boucher, even after moving libraries. Mr. Boucher came across as a gentle person; a gentleman, who soft-talked his role in society. It is only of late that his past has come back to flatter him. As an attorney he specialised in Wills, Probate and Estate Planning, and wrote upon the topic, passing his wisdom and experience down in the written word. He came to us to purchase works that he then donated to Law Libraries at American Universities, to fill gaps in their collections. Harold Boucher termed himself as an amateur legal historian, but his research, on Dr. Cowell's "The Interpreter", an early Law Dictionary, proved otherwise, as it pointed to omissions from the work not previously noted. The first edition published in 1607 had been burned by the Common Hangman, on orders of the King, as definitions in the work regarding rights and hereditaments of the Crown irritated Parliament. The book suffered suppression; John Cowell suffered the wrath of the Crown, the Commons, Coke and Bacon. For nearly four centuries no-one else had noticed the omissions of definitions for Wills and Codicils, but the entry for Testaments refers the reader to "see Wills". Harold Boucher noticed. His passing has also been noticed, with regret.

State-owned enterprise (SOE) reform has been at the heart of China's post-Mao economic reforms. Since early 1990s, a large number of Chinese SOEs have been transformed into joint stock companies, and many of them are now listed on China's domestic stock exchanges. The corporatisation and listing of the SOEs did not, however, bring about significant improvement in their performance or in the manner in which they are governed.

This book examines the effectiveness of the key legal reforms that have been put in place for addressing the governance issues facing Chinese listed companies. The focus is on three important – but understudied – aspects of corporate governance reform in China: regulation of the private sales of corporate control, institutional shareholder activism, and board level monitoring and control. 
