The Tribunals Courts & Enforcement Act 2007 will, for many debts, sweep away the old procedures and principles of enforcement and introduce a new code of law. However, some debts have been deliberately excluded from these changes. Among the liabilities in question are a wide range of shipping liabilities including harbour dues and fines, market tolls and stallages, distress damage feasant for trespassing chattels and powers of seizure of trespassing animals under the Animals Act 1971, arrests of aircraft and ecclesiastical executions. 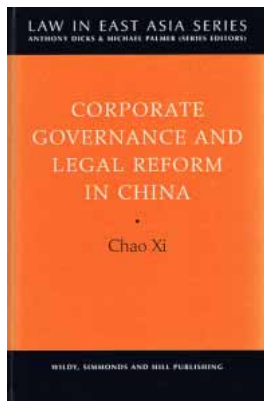

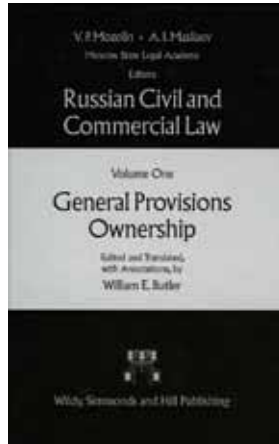
