





This book focuses on a specific component of the normative dimension of law, namely, the normative claim of law. By 'normative claim' we mean the claim that inherent in the law is an ability to guide action by generating practical reasons having a special status. The thesis that

law lays the normative claim has become a subject of controversy: it has its defenders, as well as many scholars of different orientations who have acknowledged the normative claim of law without making a point of defending it head-on. It has also come under attack from other contemporary legal theorists, and around the normative claim a lively debate has sprung up. This debate makes up the main subject of this book, which is in essence an attempt to account for the normative claim and see how its recognition moulds our understanding of the law itself. This involves (a) specifying the exact content, boundaries, quality, and essential traits of the normative claim, (b) explaining how the law can make a claim so specified, and (c) justifying why this should happen in the first place. The argument is set out in two stages, corresponding to the two parts in which the book is divided In the first part, the author introduces and discusses the meaning, status, and fundamental traits of the normative claim of law: in the second he explores some foundational questions and determines the grounds of the normative

claim of law by framing an account that elaborates on some contemporary discussions of Kant's conception of humanity as the source of the normativity of practical reason.


On Human Rights traces the idea of a natural right from its origin in the late Middle Ages, when the rights were seen as deriving from natural laws, through the seventeenth and eighteenth centuries, when the original theological background was progressively dropped and 'natural law' emptied of most of its original meaning. By the end of the Enlightenment, the term 'human rights' (droits de l'homme) appeared, marking the purge of the theological background. But the Enlightenment, in putting nothing in its place, left us with an unsatisfactory, incomplete idea of a human right. Griffin shows how the language of human rights has become debased. There are scarcely any accepted criteria, either in the academic or the public sphere, for correct

use of the term. He takes on the task of showing the way towards a determinate concept of human rights, based on their relation to the human status that we all share. He works from certain paradigm cases, such as freedom of expression and freedom of worship, to more disputed cases such as welfare rights - for instance the idea of a human right to health. His goal is a substantive account of human rights - an account with enough content to tell us whether proposed rights really are rights. Griffin emphasizes the practical as well as theoretical urgency of this goal: as the United Nations recognized in 1948 with its Universal Declaration, the idea of human rights has considerable power to improve the lot of humanity around the world

The Tribunals Courts & Enforcement Act 2007 will, for many debts, sweep away the old procedures and principles of enforcement and introduce a new code of law. 



State-owned enterprise (SOE) reform has been at the heart of China's post-Mao economic reforms. Since early 1990s, a large number of Chinese SOEs have been transformed into joint stock companies, and many of them are now listed on China's domestic stock exchanges. The corporatisation and listing of the SOEs did not, however, bring about significant improvement in their performance or in the manner in which they are governed.

This book examines the effectiveness of the key legal reforms that have been put in place for addressing the governance issues facing Chinese listed companies. The focus is on three important – but understudied – aspects of corporate governance reform in China: regulation of the private sales of corporate control, institutional shareholder activism, and board level monitoring and control.
